As a landlord for 30 years, I have dealt with a wide-range of municipal disputes. However, nothing prepared me for ticket **#2018ov400153**; a seemingly common ordinance violation ticket.

The ticket is dated 02-28-18, however, the problem began when a previous tenant of mine called the Madison city police to report that other people were parking on the stretch of gravel in front of their home. As there was no driveway, this left my tenants no place to park.

However, according to the police, the gravel area alongside the street was considered "public" parking" because there was no curb, and there was nothing the Madison city police could do. In a further attempt to resolve the parking issue, my tenant and I personally met with the chief of Madison city code enforcement. After consulting with another city official through his radio, he informed my tenant and I that there was nothing Madison City could do and my tenant "would just have to park elsewhere".

My frustrated tenant moved shortly thereafter.

Sometime later, without any prior warning by Madison City, I received ticket **# 2017ov400976** for "knowingly allowing" inoperable out-of-state vehicles to be parked in front of my property. I thought the ticket must be some sort of mistake, so I promptly called and notified the ticketing officer that I did not own the vehicles, nor did I authorize anyone to park there. I also submitted a written request to the city of Madison for the vehicles to be removed and my ticket dismissed. I did not receive any response to my written requests, and therefore it costed me much-needed working hours to appear in court.

During my 1<sup>st</sup> court appearance, I met with the Madison City attorney, Larry. I explained the situation and gave him a second copy of my written statement. After reviewing my statement, Larry dismissed the case <u>without rebuttal</u>, and wished me a good day. A few weeks later, I received ticket **#2018400153**.

This second ticket seemed strange to me, mainly because it was issued (once again without warning) for the *same* vehicles parked in the *same* location as the <u>previously adjudicated ticket</u>. During my second court appearance, I asked Larry to explain why I received the second ticket. Larry was unable to give me any explanation. Larry said that he would look into it, but unfortunately a third court appearance would be required, once again at the cost of working hours.

Sadly, Larry was not present on the day of my third appearance, so I pleaded for a dismissal to the presiding city "judge". The city "judge" (unlike Larry) was rude and condescending, and showed no interest in hearing anything that I had to say. He then said a trial would be necessary to resolve the ticket, and granted a trial by jury at my request.

However, I never got the trial by jury that I was promised. Instead my trial consisted of the same, rude city "judge", the ticketing officer, and Larry's boss as the Madison city attorney. I reluctantly agreed to proceed with the trial without the jury I was promised, because I wanted to reach a final, resolution and get on with my life. Once again, my case rested on the fact that I did not receive prior warning as required by section 90.05 of Madison City ordinance, I did not own the vehicles and I certainly did not authorize the illegal parking of inoperable, "dismantled" vehicles "with no visible registration" in front of my property. I also testified that according to city police and the Madison City head of code enforcement, the area in question was "public" parking, and therefore I had no control over vehicles parked there.

Sadly, my defense seemed to fall on the deaf ears of the now contemptuous city "judge". In contrast, the city "judge" was very affable to the Madison city attorney. The trial reached a quick conclusion, however, the city "judge" refrained from revealing his verdict until he discussed the matter further with the city's attorney. I was told that I would have to wait for the verdict, and that I would be notified via mail.

I was not notified until about a week later of my verdict: GUILTY and a \$500.00 fine.

Is this how the municipal justice system is supposed to work for those who can't afford legal representation?

What has been done to me under the pretense of municipal "justice", is certainly being done to others. Is there anyone who can help?

### **RESPONSE TO MOTION TO DENY AND/OR DISMISS THE MOTION TO RECONSIDER JUDGEMENT**

It has recently come to my attention that the Plaintiff ticketed the registered owner of the illegally parked vehicles, and then dismissed the ticket on July 26<sup>st</sup> 2018 (see 2018ov400152).

Therefore, since the underlying cause of the alleged violation does not exist, it is impossible to find the defendant liable.

### 1. The Motion to Reconsider lacks an arguable basis either in law or in fact.

I have given testimony that I <u>do not</u> own the vehicles in question, I <u>did not</u> authorize others to illegally park their disabled vehicles in front of my property, and that I had previously <u>requested police assistance</u> in removing the unwanted vehicles (see case# 2017ov400976); this is a sound basis in law.

If it is claimed that my statement is not based in fact, then I ask the plaintiff to publicly state which part of my testimony they claim is untrue.

## 2. The Motion to Reconsider is being presented for an improper purpose, so as to harass or to cause unnecessary delay or needless increase in the cost of litigation.

In case **# 2017ov400976**, I was ticketed for the <u>same</u> vehicles parked in the <u>same</u> location. During my first case hearing I meet with the plaintiff's attorney (Larry) and explained my understanding of who is responsible to "ticket or tow" illegally parked vehicles. I then provided plaintiff's attorney a copy of my written statement which I had previous filed. I assumed the issue was resolved when the plaintiff's attorney dismissed the ticket without rebuttal. I have since been summoned 4 additional times and received a fine of \$500. I can affirm that the intent of this motion is **not to** harass or cause further unnecessary delay, but to seek a just and final resolution, and establish where the legal responsibility falls regarding policing the unauthorized and illegal actions of the public.

That being said, I have no doubt that "legal" harassment is an ongoing and present issue in this case, however, I strongly bring to question which is the harassing party. The plaintiff has shown little concern thus far for the time and cost of litigation required to hire multiple attorneys (at public expense) and demand my presence for no less than 4 court appearances to revisit an already adjudicated and dismissed ticket.

## 3. The Motion to Reconsider is objectionable as to form, in that it contains statements not a part of the record, and statements that are irrelevant, immaterial, and contain improper legal conclusions.

Unlike the plaintiff, I am not in a position to afford multiple attorneys, and therefore my statements may lack the proper legal "form" in describing the injustices which have occurred. Nonetheless, I am certain the ticket is illegitimate and discriminatory, and I have described it to the best of my abilities. My statement does not contain any evidence which the plaintiff's attorney (Larry's boss) and the municipal judge were not made aware of verbally and through writing at time of my supposed "trial".

Furthermore, I disagree that my statement contains an "improper legal conclusion", as it seems reasonable to conclude that I should not be held responsible for the unauthorized actions of others. I believe it necessary that an unbiased, higher court establish whom is responsible to police public citizens parking. Specifically, should the hapless victim be held accountable for the tickets and fines, or should the perpetrator and/or owner of the vehicle be held accountable?

## 4. The allegations and other factual contentions set forth in support of the Motion to Reconsider have no evidentiary support in the record.

This is admittedly true, the judge in case #2018ov400153 has a provable history of bias, and denying the defendant's right to enter evidence into the public record. This is especially true in municipalities ran by politics and cronyism, see case #2016ov400378 for an additional example. The "justice" I was given is the same justice others are receiving and the judge should be ashamed of himself.

### <u>ORDER</u>

This matter came for hearing August 16, 2018 on Defendant's Post-Trial Motion. Defendant was present pro se. Attorney Papa was present for the City of Madison. At the close of the hearing, Defendant was advised that his Post-Trial Motion was denied and that a formal, Final Order would follow. Defendant was also advised of his right to appeal within thirty days of entry of the written order.

This ordinance violation arose on March 1, 2018, when the City of Madison filed against Defendant for abandoned or inoperable vehicles on Defendant's property, for the date of February 26, 2018. Defendant is the landlord at that location and has several rental properties.

On June 14, 2018, the matter was called for non-jury trial. City Inspector Shelby and the Defendant testified. Shelby is a former Madison Police Officer. Defendant was found guilty and given a total fine and costs of \$500.

Defendant filed a Post-Trial Motion on July 6, 2018 and said it was "based on the attached statement." The Defendant claims that at his appearance, at which the City Attorney did not appear, Defendant pleaded for dismissal but the judge was "rude and condescending" for not giving the relief asked and dismissing the ordinance violation at his appearance.

There are many false accusations and characterizations made by Defendant in his statement. He falsely claims to have asked for a jury trial. There was no such request, no written jury demand and no payment of jury fee.

During the non-jury trial, objections were made and sustained at Defendant's attempts to testify concerning matters that were irrelevant and unreliable. Defendant took offense that objections were sustained against those improper attempts.

At the trial, the Court weighed the testimony and evidence presented. The City Inspector was a former Madison Police Chief. His testimony was matter of fact and believable. Defendant was not believable. That lack of credibility is buttressed by his subsequent false pleadings in his Post-Trial Motion.




