1. I respectfully request a written letter of explanation as to why public records are devoid of any mention of my May 2nd court appearance (to my knowledge).
2. Please add the enclosed [**ADDENDUM: Complaint to Granite city**] as an addendum to my Letter of Complaint.
3. I respectfully request a written letter of explanation as to why court records now show that I have an appearance scheduled for May 9th (case 2019ov400178), even though I have not yet received a written ticket, citation, or notice to appear.
4. I would respectfully request that all 13 identical violations be combined into a single case so that they may be litigated simultaneously. I am a single landlord, yet I have been charged with the same offense in 13 separate cases, with varied court appearances.
