Bystander's Report June 25th

While waiting to be called before the hearing officer, I was approached by a Granite city representative who asked me why I was there (at court) today. I replied that I was called to court due to an ordinance violation that allegedly occurred at a property I own (2506 Iowa).

The city representative then stated he would look into the matter.

I watched as the representative I had spoken to consulted with the presiding Granite city hearing officer and at least two other representatives from Granite city crime-free police. The hearing officer then called me for my hearing.

The hearing officer stated that he had found two outstanding ordinance violations in city records for 2506 Iowa, "one for trash and one for no occupancy permit". He went on to state that Granite city was going to give me a "2 for 1 deal" today, and litigate "both (the violations) together".

I was then asked by the hearing officer "What do you have to say regarding the two complaints?" To which I responded by stating a brief summary, and offering the hearing officer a copy of my previously filed statement (See **EXHIBIT K-2**). However, the hearing officer declined to accept the copy of my statement.

I watched as the hearing officer proceeded to consult with other city officials, crime-free police, and a Granite city attorney. After speaking with the other city officials, the hearing officer informed me that both tickets would be dismissed.

I then asked the hearing officer about my next scheduled court hearing concerning these tickets. The Granite city attorney then stated something to the effect of "Not to worry, we (Granite city) will take care of it".
