In early 2016, I refused a Granite City Police Captain's demand to evict a tenant and his pregnant fiancee (both claimed to be innocent) from their home. This happened before any lawful trial or relevant conviction of the accused. Soon after my refusal, I received a barrage of frivolous tickets in a blatant attempt by the Granite City Police to intimidate me and impede my lawfully licensed Granite City business, Warrant/ticket #1600400378 was just one of many frivolous unwarranted tickets.

Before receiving the said ticket #1600400378 for an occupancy code violation at my house on Iowa, I had already notified the Granite City Occupancy Code department that unknown occupants were living in my house on Iowa street and that I had already filed for their eviction on May 4th, 2016(case# 16LM401). Hence, the Granite City Occupancy Code department never issued a ticket for any occupancy code violation at said house. In fact, they later issued an occupancy permit for the next tenants with no mention of any unpaid occupancy code violation ticket.

I had also requested (to no avail) that the Granite City Police remove the "unknown occupants" from said house. Much to my surprise, the Granite City Police issued me a ticket for the violation shortly afterward. Thinking the ticket must be a mistake, I notified the Granite Police in writing of the situation. I was later verbally told by a Granite City Police representative that the situation was resolved to the Police and the City of Granite City's satisfaction with no longer any need for me to appear.

The City of Granite then renewed my landlord business license in 2017 with no mention of an unpaid Granite City Occupancy code ticket or Granite City arrest warrant for a NON-EXISTENT Granite City code violation.

Since the issuance of the arrest warrant, I have appeared in Granite City court in the presence of the Granite City Police and Granite City attorneys multiple times with no mention of an outstanding warrant. In early 2017, I contacted and physically met with Granite City Police concerning issues at another Granite city property that I own. The Granite City Police showed no concern for any outstanding unpaid ticket and made no mention of any Granite City arrest warrant.

Instead, the Granite City Police chose a Saturday afternoon (just after the banks had closed) before bringing to my attention the nearly 1 year old warrant. I quickly informed the Granite City Police Arresting Officer that I live in Granite City. I stated that I had no desire to move or flee the country. I promised to turn myself in on Monday morning and quickly resolve the issue when both the banks and the Circuit Clerk's office would be open. Once again, much to my surprise, the Granite City Police chose instead to handcuff and arrest me in front of my son, then demanded \$600.00 cash on a Saturday in exchange for my release.
